In the French schooner "La Laure" at sea to which they had been removed from the Spanish schooner "Emmanuel" at the Sherbro, where she ran aground and became a total wreck) by His Majesty's Ship "Atholl" Alexander Gordon Square Commander.	Landed at Aberdeen in the month of October 1829, but were not delivered over to the department, until the 1st January 1831. during which period they were supported at the expence of Captain Gordon.			
<p>The Commissioners under the Treaty for the abolition of the African slave trade, in this Colony having refused to receive this case in the British and Spanish Mixed Commissions, the matter was referred to the Principal Secretary of the African Affairs for his decision, but no instructions having arrived on the 31 Decr 1830, it was considered right to relieve the papers of the heavy expence of supporting the Agents after they date, and the whole of the proceedings were accordingly received over and dealt with, as if delivered over by the Mixed Commissions as emancipated slaves.</p>
